# BY-LAW

Number 6-2014

**A By-law to amend the Schedules of Traffic By-law 93-93, relating to SCHOOL BUS LOADING ZONE (Schedule VIII), NO STOPPING (Schedule XV), DESIGNATED TURNING LANES (Schedule VI), FIRE ROUTES (Schedule XXII), THROUGH HIGHWAYS (Schedule III) and STOP SIGNS (Schedule IV)**

The Council of The Corporation of the City of Brampton HEREBY ENACTS AS FOLLOWS:

1. By-law 93-93 as amended, is hereby further amended by DELETING the following items from Schedule VIII:
