**A By-law to amend the Schedules of Traffic By-law 93-93,
relating to THROUGH HIGHWAYS (Schedule III) and
STOP SIGNS (Schedule IV)**

The Council of the Corporation of the City of Brampton HEREBY ENACTS AS FOLLOWS:

1. By-law 93-93 as amended, is hereby further amended by DELETING the following items from Schedule III:

Sunforest Drive	The south limit of Tremblay Street and the north limit of Wexford Road
Elmgrove Avenue	The west limit of Fairglen Avenue (easterly intersection) and the west limit of Pleasantview Avenue
Reynier Drive	The west limit of Richvale Drive South (southerly intersection) and the west limit of Richvale Drive South (northerly intersection)

2. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule III:


Sunforest Drive	The south limit of Tremblay Street and the north limit of Coronation Circle
Sunforest Drive	The south limit of Coronation Circle and the north limit of Wexford Road
Elmgrove Avenue	The west limit of Fairglen Avenue (easterly intersection) and the west limit of Sunset Boulevard
Reynier Drive	The west limit of Richvale Drive South (southerly intersection) and the south limit of Piedmont Drive/Sparklett Crescent
Reynier Drive	The north limit of Piedmont Drive/Sparklett Crescent and the west limit of Richvale Drive South (northerly intersection)


- 3. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule IV:




