**A By-law to amend the Schedules of Traffic By-law 93-93,
relating to U-TURNS (Schedule II), NO STOPPING (Schedule XV),
STOP SIGNS (Schedule IV), THROUGH HIGHWAYS (Schedule III) and
FIRE ROUTES (Schedule XXII)**

The Council of The Corporation of the City of Brampton HEREBY ENACTS AS FOLLOWS:

1. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule II:

U-TURNS

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Financial Drive	A point 10 meters south of Sacramento Road/Wardsville Drive and a point 10 meters north of Sacramento Road/Wardsville Drive
Fairlawn Boulevard	Ridgefield Crescent and Vanwood Crescent (southerly intersection)

2. By-law 93-93 as amended, is hereby further amended by ADDING the following items to Schedule XV:

Honeyview Trail	The south limit of Castlemore Road and the south limit of the roadway
Haverstock Crescent	The west limit of Robert Parkinson Drive (northerly intersection) and the west limit of Robert Parkinson Drive (southerly intersection)
Richmead Road	The east limit of James Potter Road and the east limit of the roadway
Semley Street	The east limit of James Potter Road and the west limit of Durango Drive
Truro Circle	The north limit of Taurus Road and the west limit of Robert Parkinson Drive
Taurus Road	The east limit of Truro Circle (westerly intersection) and the west limit of Robert Parkinson Drive
Terrick Road	The south limit of Truro Circle and the north limit of Haverstock Crescent
Tysonville Circle	The west limit of Veterans Drive and the west limit of intersection of Tysonville Circle with itself
New Pines Trail	The north limit of the roadway and the north limit of Heart Lake Road
