	To Change the Name of A.B.B. Court	

WHEREAS the Council of the Corporation of the City of Brampton deems it necessary to change the name of A.B.B. Court;

AND WHEREAS notice of the intention to pass this by-law has been published once a week for four successive weeks in The Brampton Guardian, a newspaper having general circulation in the City of Brampton;

AND WHEREAS Council has heard all persons who claimed that they would be adversely affected by this by-law and who applied to be heard;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

- 1. The name of the portion of A.B.B. Court north of Westcreek Boulevard as shown in Schedule "A" attached hereto is changed to "Volans Court".
- 2. The name of the portion of A.B.B. Court south of Westcreek Boulevard to the northerly boundary of the 407 Highway as shown in Schedule "A" attached hereto is changed to "Westcreek Boulevard".
- 3. The name of the portion of A.B.B. Court south of the 407 Highway as shown in Schedule "A" attached hereto is restored to its former name "Farmhouse Court".
- 4. The affidavit of Leonard J. Mikulich attached as Schedule "B" hereto shall form part of this by-law.


READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 15th day of January, 2001.
