A by-law to amend Fee By-law  
380-2003, as amended

WHEREAS By-law 380-2003 was passed pursuant to the *Municipal Act, 2001*, S.O. 2001, c. 25, s. 391(1) to impose fees or charges;

AND WHEREAS, by resolution C006-2007, City Council has approved the fee amendments identified below;




4. That all reference to the Legal Services Department be changed to the Corporate Services Department to reflect organizational changes.


