To establish certain lands as part of public highways

1. The lands acquired by The Corporation of the City of Brampton and described in Schedule A to this by-law shall be established as parts of the public highway system upon registration in the land registry office of Draft Plan of Subdivision 21T-92025B (Plan 2).
