WHEREAS it is deemed expedient in the interest of

The Corporation of the City of Brampton that parts of Regentview

Drive and Monte Vista Trail and all of Wishart Place be realigned;

AND WHEREAS to effect such a realignment it is necessary that certain parts of Regentview Drive and Monte Vista Trail and all of Wishart Place be stopped up and closed and sold to the owners of the abutting lands;

AND WHEREAS notice of the intention to pass this by-law has been published once a week for four consecutive weeks in the Daily Times and The Guardian, newspapers published in the City of Brampton;

AND WHEREAS the said Corporation has given notice to The Regional Municipality of Peel, pursuant to section 49 of the Regional Municipality of Peel Act (R.S.O. 1980, c. 440, as amended) and The Regional Municipality of Peel has indicated that it does not object to such stopping up;

AND WHEREAS the Council for the said Corporation has heard in person or by his counsel, solicitor or agent, all persons claiming that their land will be prejudicially affected by this by-law and who applied to be heard;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:
