## THE LAND TITLES ACT TRANSFER OF EASEMENT

MOORVILLE PROPERTIES INC.,

the registered owner of freehold land registered in the Land Registry Office for the Land Titles Division of Peel (No. 43) as

the rights and easements hereinafter described, namely:

the free, uninterrupted and unobstructed right and easement in perpetuity to enter on and construct, install, operate, maintain, inspect, repair, alter, replace and remove any storm sewers, all necessary culverts, catch basins, pipes, conduits, equipment, and all appurtenances or accessories thereto as the Transferee may from time to time or at any time hereafter deem requisite, upon, under, along and across the lands described in Schedule 'A' hereto;

TOGETHER with the right of free, uninterrupted and unobstructed access for the Transferee, its servants, agents, workmen, vehicles, supplies and equipment at all times and for all purposes and things necessary for or incidental to the exercise and enjoyment of the rights hereby transferred over such portion of the above-mentioned parcel as may from time to time be unencumbered by any building or other structure, fences excepted, to and from the lands described in Schedule 'A' hereto;

The Transferee covenants and agrees with the Transferor that it shall as far as possible restore the surface to the same condition as prior to the commencement of construction or of any subsequent work thereto, and shall replace or restore any soil or turf removed in connection with any of the work referred to above. The Transferor covenants to remove and not to construct or erect any buildings, structures or improvements upon, under, along or across the lands described in Schedule 'A' hereto nor in any way interfere with the easement hereby granted to the Transferee, and the Transferor does further covenant that no alteration shall be made in the grading of the lands described in Schedule 'A' hereto by the Transferor, its agents, servants or workmen, without the written consent of the Commissioner of Public Works for the City of Brampton.

The Transferor hereby agrees that the Transferee shall have the right to sever, fell, cut, trim and remove at any time all trees, shrubs, bushes and branches, stumps and roots, and to prevent or control the growth of same within the limits of the servient lands, which may at any time interfere with or endanger the operation of the said sewers or drainage works.

The Chargees hereby consent to the granting of the property rights hereby transferred and hereby postpone their charges in favour thereof.

THIS INDENTURE and everything herein contained shall extend to and include the parties hereto and their respective successors and assigns.
