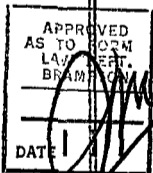
To amend By-law 200-82, (Part 11, Plan 43R-10580, part of Lot 7, Concession 1, W.H.S., in the geographic Township of Chinguacousy)

The council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 200-82, as amended, is hereby further amended:
 - (1) by changing, on Sheet 6 of Schedule A thereto, the zoning designation of the land shown outlined on Schedule A to this by-law from RESIDENTIAL EXTENDED ZONE (R2B) to COMMERCIAL ONE - SECTION 184 (C1-SECTION 184), such lands being Part 11, Plan 43R-10580, part of Lot 7, Concession 1, W.H.S., in the geographic Township of Chinguacousy.
 - (2) by deleting therefrom Schedule C - Section 184 thereto and substituting therefor Schedule B to this by-law.

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL,

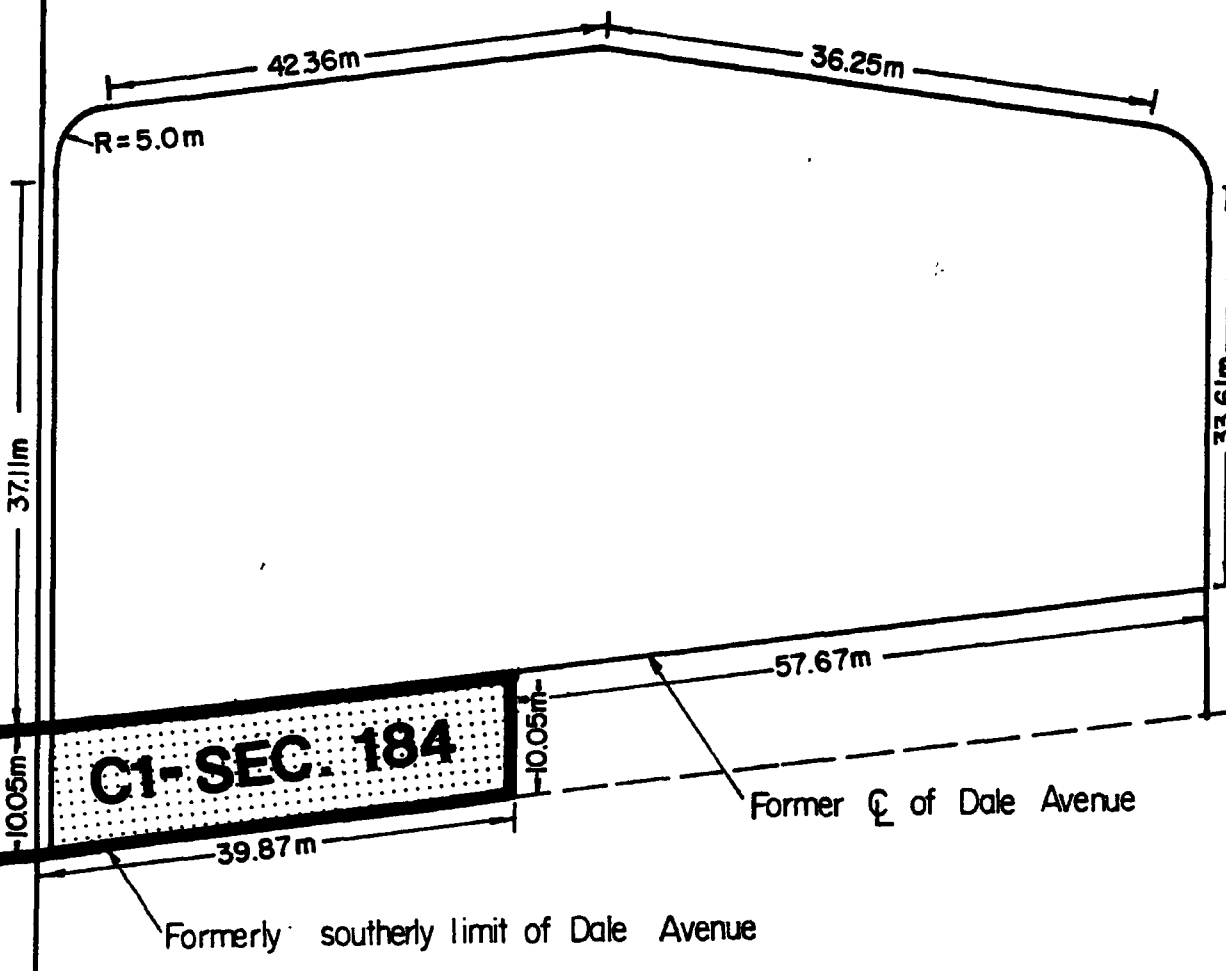
