I VELITATION			

To establish certain lands as part of Bramalea Road and Peter Robertson Boulevard

The Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

- 1. The lands owned by The Corporation of the City of Brampton, the successor to The Corporation of the Township of Chinguacousy pursuant to the provisions of the Regional Municipality of Peel Act described in Schedule A to this by-law are hereby established as part of the public highway system.
- 2. The lands described firstly and secondly in Schedule A are part of Bramalea Road. The lands described thirdly in Schedule A are part of Peter Robertson Boulevard.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 27th day of January, 1997.

FIRSTLY:

ALL AND SINGULAR that certain parcel or tract of land and premises situate, lying and being in the City of Brampton in the Regional Municipality of Peel formerly in the Township of Chinguacousy, County of Peel and containing by admeasurement an area of 0.393 acres being the same or less and being composed of part of Lot 11 in Concession 5, East of Hurontario Street in the said Township the limits of which said parcel of land may be more particularly described as follows:

PREMISING that the Northwesterly limit of the King's Highway Number 7 has an assumed bearing of North 39 degrees 30 minutes 30 seconds East in accordance with the Department of Highways Plan P-1899-15 and relating all bearings herein thereto;

COMMENCING at a survey monument at the most Westerly angle of the West half of the said Lot 11 in Concession 5, East of Hurontario Street;

THENCE South 44 degrees 17 minutes 10 seconds East along the South-west limit of the said West half of Lot 5 a distance of 1,007.09 feet;

THENCE North 39 degrees 14 minutes 30 seconds East 17.11 feet to a survey monument;

THENCE North 44 degrees 17 minutes 10 seconds West along a line drawn parallel to the said South-westerly limit of Lot 5 and distant 17.00 feet measured North-easterly therefrom and at right angles thereto 1,002.80 feet to a survey monument;

THENCE North 44 degrees 17 minutes 40 seconds West along a line drawn parallel to the South-westerly limit of the West half of Lot 12 in Concession 5, East of Hurontario Street and distant 17.00 feet measured North-easterly therefrom and at right angles thereto 4.27 feet to its intersection with the North-westerly limit of the said West half of Lot 11 in Concession 5, East of Hurontario Street;

THENCE South 39 degrees 11 minutes 00 seconds West along the last mentioned North-westerly limit 17.11 feet to the point of commencement.
