- 2. By-law 33-79, as amended, is hereby further amended by the addition to Schedule I thereof the following items under the appropriate columns thereof:

NO PARKING ON SPECIFIED HIGHWAYS

Table with 4 columns: Highway, Side, Between, Times or Days. Rows 1-5: Main Street North, West, various 'Between' descriptions, and 'Anytime' or 'Anytime Except 8:00 AM-1:00 PM Sundays'

Main Street North	West	A point 60 metres north of Church Street and Nelson Street East	Anytime
