To amend By-law 139-80, as
amended (building permits)

The Council of The Corporation of the City of Brampton hereby
ENACTS as follows:

1. By-law 139-80, as amended by By-law 8-83, is hereby further
amended:

(1) by deleting therefrom section 9(1), and substituting
therefor the following:

"9(1)(a) Plans examination fees shall be paid when
an application for a permit is submitted.

(b) All other fees required in connection with
each application for each type or class of
permit shall be paid when the permit is
issued."

(2) by deleting therefrom section 9(5), and substituting
therefor the following:


"9(5) Where continuous or special inspection is
required in connection with any matter, or
where the applicant requests any inspection
outside normal business hours, the fee
shall be as set out in Schedule A to this
by-law."

(3) by deleting therefrom Schedule A, and substituting therefor Schedule A to this by-law.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 23rd day of January , 1984.



Schedule "A" to By-law 139-80
 (amended by By-law 25-84)
CLASSES OF PERMITS & PERMIT FEES

<u>Class or type of permit</u>	<u>Permit fees</u>
1. Construction, reconstruction of a building (including additions, foundations, garages, carports, accessory buildings.)	\$8.00 for each \$1,000.00 of the cost of the work. (Minimum \$15.00) <u>Plus a plans examination charge, calculated in accordance with the table below.</u> <u>Plus a final inspection charge as in the table below.</u>

PLANS EXAMINATION FEE TABLE

Gross Floor Area of Building or Addition.	Charge per Application.
500 - 1,000sq.ft.	\$25.00
1,001 - 2,000sq.ft.	\$50.00
2,001 - 10,000sq.ft.	\$75.00
10,001 - 50,000sq.ft.	\$100.00
50,001 - 100,000sq.ft.	\$250.00
100,00sq.ft. or greater	\$500.00

FINAL INSPECTION FEE TABLE

For each new residential dwelling	\$10.00
For each new industrial, commercial, or institutional building	\$50.00
For an addition to an industrial, commercial, institutional building	\$50.00

2. Alterations or repairs to a building. Pools and pool fences.	\$8.00 for each \$1,000.00 of the cost of the work. (Minimum \$15.00)
3. Demolition or removal of a building, or part thereof	\$35.00
4. Installation of a storage tank having a capacity of 1,000 gallons or more.	\$25.00 for each tank.
5. Installation of gasoline pumps	\$10.00 for each pump
6. Erection and construction of a temporary building	\$35.00
7. Installation of any type of heating system	\$15.00 plus \$8.00 for each 10,000 btu/hr of building heat loss, or part thereof, up to a total of 1 million btu/hr heat loss, and \$5.00 for each 10,000 btu/hr of building heat loss thereafter.
8. Alteration or additions to, or replacement of, existing heating system, where building is altered or expanded.	\$15.00 plus \$8.00 for each 10,000 btu/hr of building heat loss, or part thereof, calculated on the building addition, or on the part the heating system serves.
9. Installation of independent space heater, or pool heater	\$15.00 each
10. Replacement or renewal of furnace	\$15.00 each.
11. Installation of conversion burner or add-on heat pump	\$15.00 each
12. Continuous or Special Inspection (where required)	\$25.00 per hour or any part thereof.
13. Installation of add-on air-conditioning unit	\$15.00 each.
14. Fee for inspection outside normal working hours	\$25.00 per hour or any part thereof.
