THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number <u>26-95</u>

To accept and assume works in Registered Plan M-285, and to establish lands as public highways

WHEREAS the Council of The Corporation of the City of Brampton has, by resolution, decided that all works constructed and installed in accordance with the subdivision agreement for Registered Plan M-285 be accepted and assumed.

AND WHEREAS Council has authorized the City Treasurer to release all securities held by the City in connection with the development of Registered Plan M-285.

AND WHEREAS it is deemed expedient to accept and assume the streets (and street widenings, when applicable) on Registered Plan M-285 as part of the public highway system (and to establish certain other lands as public highways, when applicable).

NOW THEREFORE the Council of The Corporation of the City of Brampton hereby **ENACTS** as follows:

- 1. All of the works constructed and installed in accordance with the subdivision agreement for Registered Plan M-285 are hereby accepted and assumed.
- 2. The lands described in Schedule A to this by-law are hereby accepted and assumed as part of the public highway system of the City of Brampton.
- 3. The lands acquired by the City of Brampton and described in Schedule B to this by-law are hereby established as parts of public highways.
- 4. By-law No. 186-95 is repealed.

DESCRIPTION OF PUBLIC LANDS

Van Kirk Drive and Sandalwood Parkway and Block E According to Registered Plan M-285 City of Brampton Regional Municipality of Peel
