# BY-LAW

Number 26-2004

To amend By-law 93-93,

## **THROUGH HIGHWAYS, NO PARKING**

The council of the Corporation of the City of Brampton hereby ENACTS as follows:

1. By-law 93-93, as amended, is hereby further amended as follows:

(1) by deleting from Schedule III thereto the following items:

### **THROUGH HIGHWAYS**

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Edenbrook Hill Drive	The south limit of River Rock Crescent and the north limit of Tideland Drive
Robertson Davies Drive	The north limit of the road and the north limit of Mayfield Road
Silktop Trail	The east limit of Mint Leaf Boulevard (westerly intersection) and the north limit of Steeplebush Avenue
Steeplebush Avenue	The east limit of Barleyfield Road and the east limit of the road

(2) by adding to Schedule III thereto the following items:

### **THROUGH HIGHWAYS**

COLUMN 1 HIGHWAY	COLUMN 2 BETWEEN
Richvale Drive	The south limit of Notre Dame Avenue and the north limit of Bovaird Drive
Edenbrook Hill Drive	The south limit of River Rock Crescent (south intersection) and the north limit of Tideland Drive
Silktop Trail	The east limit of Mint Leaf Boulevard (westerly intersection) and the east limit of Silktop Trail
Steeplebush Avenue	The east limit of Barleyfield Road and the west limit of Torbram Road

(3) by deleting from Schedule XIV thereto the following items:



Knightsbridge Drive	North	A point 89 metres west of Kings Cross Road and a point 52 metres west thereof	Anytime
Bartley Bull Parkway	Interior Side (Clockwise)	Most southerly limit of Lot 623, R.P. 695 and Duncan Bull Parkway	Anytime
East Drive	Both	Bramalea Road and Tobram Road	Anytime

(4) by adding to Schedule XIV thereto the following items:

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Knightsbridge Road	North	A point 89 metres west of Kings Cross Road and a point 52 metres west thereof	Anytime
Bartley Bull Parkway	Interior Side (Clockwise)	Most southerly limit of Lot 623, R.P. 695 and Duncan Bull Drive	Anytime
East Drive	Both	Bramalea Road and Torbram Road	Anytime


