# BY-LAW

Number 26-2006

To Appoint Municipal By-law Enforcement Officers and to Repeal By-law 242-2005

WHEREAS section 8 of the *Municipal Act* (S.O. 2001, c. M.25, as amended) gives powers and privileges of a natural person for exercising its authority under the *Municipal Act* or any other Act;

AND WHEREAS section 227 of the *Municipal Act*, (S.O. 2001, c. M.25, as amended) establishes the role of employees to carry out duties required or assigned under the *Municipal Act* or any other Act;


AND WHEREAS section 15 of the *Police Services Act* (R.S.O. 1990, c. P.15, as amended) authorizes the appointment of Municipal Law Enforcement Officers who shall be peace officers for the purposes of enforcing the by-laws of the Municipality;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. The persons named in Schedule I attached hereto are hereby appointed as Municipal Law Enforcement Officers for the City of Brampton.
2. By-law 242-2005 is hereby repealed.
