BRAMALEA LIMITED, a corporation incorporated pursuant to the laws of the Province of Ontario,

herein called "Bramalea"

of the SECOND PART;

WHEREAS Bramalea is the owner of the lands described in Schedule "A" and proposes to develop the same in the future;

AND WHEREAS the parties have agreed that the lands described in Schedule "B" will be required by the City for park purposes in connection with any proposed development of the lands in Schedule "A";

AND WHEREAS Amex Developments Limited, the owner of the adjacent lands to the North are proposing to register a plan of subdivision forthwith;

AND WHEREAS the City are desirous of now acquiring the lands in Schedule "B" in conjunction with the development of the adjacent lands;

AND WHEREAS Bramalea has agreed to facilitate the City's request on the terms and conditions herein set out;

WITNESSETH that in consideration of the premises, other good and valuable consideration and the sum of ONE (\$1.00) DOLLAR, now paid by each of the parties hereto to each of the other of them, the parties hereto agree each with the other of them as follows: 1. Bramalea agrees to forthwith convey the lands described in Schedule "B" to the City for park purposes in accordance with the requirements of The Planning Act, (R.S.O. 1970) and amendments thereto and re-enactments thereof. 2. The City agrees that the conveyance of the lands in Schedule "B" shall be credited to Bramalea by the City and applied towards the obligations of Bramalea to provide parklands for the lands in Schedule "A" pursuant to the requirements of The Planning Act, (R.S.O. 1970) and amendments thereto and re-enactments thereof.

IN WITNESS WHEREOF the parties hereto have hereunto caused to be affixed their corporate seals under the hands of their proper officers duly authorized in that behalf.
