City of Brampton ENACTS as follows:

1. The land described in Schedule A to this by-law
be and the same is hereby accepted and assumed as
part of the public highway system of the City of
Brampton.

Open Council this 22nd day of February , 1982.

SCHEDULE A TO BY-LAW 30-82

The land situated in the City of Brampton, in the Regional Municipality of Peel, being:

- FIRSTLY: the whole of the part of Blueridge Square shown on a plan of subdivision registered in the Land Registry Office for the Land Titles Division of Peel (No. 43) as M-99;
- SECONDLY: the whole of the part of Monterey Avenue shown on the said Registered Plan M-99;
- THIRDLY: the whole of the part of Cantrill Court shown on the said Registered Plan M-99;
- FOURTHLY: the whole of the part of Mount Forest Drive shown on the said Registered Plan M-99;
- FIFTHLY: the whole of the part of Darwin Place shown on the said Registered Plan M-99;
- SIXTHLY: the whole of the part of Shelbourne Court shown on the said Registered Plan M-99; and
- SEVENTHLY: the whole of Block C, according to the said Registered Plan M-99.
