THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW NO. 31-75

To regulate the operation of Motorized Snow Vehicles within certain areas of the City of Brampton including any Highways therein or any part or parts thereof.

WHEREAS Section 6 (2) of The Motorized Snow Vehicles Act 1974, provides that the Council of a City may pass By-laws regulating, governing or prohibiting the operation of Motorized Snow Vehicles within the municipality including any highway or any part or parts thereof;

NOW THEREFORE the Council of the Corporation of the City of Brampton hereby ENACTS as follows:

- In this By-law, "Motorized Snow Vehicle" means a self-propelled vehicle designed to be driven primarily on snow.
- 2. No person shall operate a motorized snow vehicle within the area set out in Schedule "A" hereto, except on a parcel of land in excess of two acres.
- 3. Within the area set out on Schedule "A" no person shall operate a motorized snow vehicle within 300 feet of a residential dwelling on lands abutting the lands on which the operation of a motorized snow vehicle is permitted.
- 4. That the operating of a motorized snow vehicle along any highway or part of any highway under the jurisdiction of the Corporation of the City of Brampton and under the jurisdiction of the Regional Municipality of Peel within the area set out in Schedule "A" hereto is hereby prohibited, except when such motorized snow vehicle is being operated for the purpose of and while actually in the process of being loaded onto or unloaded from a vehicle or trailer, or for the purpose of and while actually in the process of crossing of a highway in accordance with paragraph 5.
- 5. No person shall operate a motorized snow vehicle across a highway except at an angle of approximately 90 degrees to the direction of the highway.

- 6. The operating of motorized snow vehicles along or across such part of any such highways as may be necessary in the discretion of the Council for the purpose only of gaining access from one part of the route to another part thereof in an organized event during the period of the Winter Carnival in the City of Brampton may be permitted by resolution of Council on such dates and at such hours during the said period as the resolution shall provide. The resolution shall designate the part of the highway or highways referred to.
- 7. The provisions of this By-law do not apply to the operation of motorized snow vehicles during an emergency or any vehicles of the Peel Regional Police Department.
- 8. Every person who contravenes any provision of this By-law is guilty of an offence and on summary conviction is liable to a fee of not exceeding three hundred (\$300.00) dollars exclusive of costs.

1. The area bordered by the west side of Airport Road and the east side of Second Line West and the south side of Number Ten (#10) side road and the north side of Steeles Avenue excepting thereout and therefrom the east half of Lot 8, Concession 6, east of Hurontario Street.

2. All the lands comprising Registered Plan 406.
