Registered Plan M-101


WHEREAS it is deemed expedient to accept and

and assumed as part of the public highway  
system of the City of Brampton.

SCHEDULE A TO BY-LAW 32-82

The land situated in the City of Brampton, in the Regional Municipality of Peel, being:

- FIRSTLY: the whole of the part of Somerset Drive shown on a plan of subdivision registered in the Land Registry Office for the Land Titles Division of Peel (No. 43) as M-101;
- SECONDLY: the whole of the part of Fanshawe Drive shown on said Registered Plan M-101;
- THIRDLY: the whole of the part of Thatcher Court shown on said Registered Plan M-101;
- FOURTHLY: the whole of the part of Traverston Court shown on said Registered Plan M-101;
- FIFTHLY: the whole of the part of Nottawasaga Crescent shown on said Registered Plan M-101, and
- SIXTHLY: the whole of Block H according to said Registered Plan M-101.
