To amend By-law 200-82 (Lot 3 Registered Plan 506, being part of Lot 5, Concession 1, E.H.S. in the geographic Township of Chinguacousy)

The Council of The Corporation of the City of Brampton ENACTS as follows:

- 1. By-law 200-82, as amended, and as specifically amended by By-law 247-90 is hereby further amended:
 - (1) by changing, on Sheet 29 of Schedule A thereto, the zoning designation of the land shown outlined on Schedule A to this by-law from RESIDENTIAL SINGLE FAMILY B (R1B) to INSTITUTIONAL TWO-SECTION 345, such lands being Lot 3, Registered Plan 506, being part of Lot 5, Concession 1, East of Hurontario Street, in the geographic Township of Chinguacousy, now in the City of Brampton.
 - (2) by deleting therefrom Schedule C Section 345.
 - (3) by adding thereto as Schedule C Section 345 Schedule B to this By-law.





DECLARATION

I, KATHRYN ZAMMIT, of the City of Brampton, in the Region of Peel, DO SOLEMNLY DECLARE THAT:

- 1. I am the Deputy Clerk of The Corporation of the City of Brampton and as such have knowledge of the matters herein declared.
- 2. By-law 246-90 which adopted Official Plan Amendment Number 191 was passed by the Council of the Corporation of Brampton at its meeting held on November 12th, 1990, and approved by the Ministry of Municipal Affairs on April 8th, 1991.
- 3. By-law 32-91 to amend Zoning By-law 200-82 (geographic Township of Chinguacousy) was passed by Council of the Corporation of Brampton at its meeting held on February 25th, 1991.
- 4. Written notice of By-law 32-91 as required by section 34 (17) of the <u>Planning Act, 1983</u> was given on March 5th, 1991, in the manner and in the form and to the persons and agencies prescribed by the <u>Planning Act, 1983</u>, the last day for appeal being March 25th, 1991.
- 5. An appeal under section 34 (18) of the Planning Act, 1983 had been filed on or before the last day for appeal. The Board orders that the appeal against By-law 32-91 is dismissed. Board Order R 910158.
