WHEREAS the Council of The Corporation of the City of Brampton deems it expedient to change the names of Hannah Street and East Service Road to Theatre Lane;

AND WHEREAS notice of the intention to pass this by-law has been published once a week for four successive weeks in the Brampton Guardian, a newspaper having general circulation in the City of Brampton;

AND WHEREAS the Council has heard all persons who claimed that they would be adversely affected by this by-law and who applied to be heard.

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

- The names of the streets known as "Hannah Street" and "East Service 1. Road" which are described in Schedule A attached hereto, are changed to "Theatre Lane".
- The affidavit of Leonard J. Mikulich attached as Schedule B hereto shall 2. form part of this by-law.

READ a FIRST, SECOND, AND THIRD TIME, and PASSED in Open Council this 23rd day of February, 1998.


The following location map shows the location of existing "Hannah Street" and "East Service Road" together with the location of "Festive Lane" or "Theatre Lane"...
