

THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number _____ 36-99

To amend By-law 151-88 as amended.

The Council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 151-88, as amended, is hereby further amended:

- by changing on Sheet 56A of Schedule "A" thereto, the zoning designation of the lands shown outlined on Schedule "A" to this bylaw from RECREATION COMMERCIAL - SECTION 560 (RC-SECTION 560) and AGRICULTURAL (A) to RESIDENTIAL SINGLE FAMILY A - SECTION 909 (R1A - SECTION 909).
- (2) by adding to the list of schedules in section 3.2 thereto the following:
 "Schedule C Section 909"
- (3) by adding thereto the following section:
 - "909 The lands designated R1A SECTION 909 on Sheet 56A of Schedule A to this by-law:
 - 909.1 shall only be used for the purposes permitted by the Residential Single Family A (R1A) Zone;
 - 909.2 shall be subject to the following requirements and restrictions:

By-1aw 36-99

(a) Minimum Lot Width:

Interior Lot - 21 metres Corner Lot - 24 metres

(b) Minimum Lot Area:

Interior Lot - 735 square metres Corner Lot - 840 square metres

- Minimum Landscaped Open Space 50 percent of the area within the required minimum Front Yard Depth
- 909.3 the lands shown on Schedule C Section 909 shall only be used for private open space purposes wherein the erection of any buildings and structures, including swimming pools, decks and patios or part thereof, is prohibited.
- 909.4 shall also be subject to the requirements and restrictions of the R1A zone and all the general requirements and restrictions of this by-law which are not in conflict with those in sections 909.2 and 909.3."
- (4) by adding thereto SCHEDULE C SECTION 909 shown as Schedule B to this by-law.

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL, this **22nd** day of **Feb.**, 1999.




