



THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 37-77

A By-law to amend the Penalty Section of certain By-laws passed pursuant to Section 35, Planning Act, R.S.O. 1970, as amended, to conform to Section 466 of The Municipal Act, R.S.O. 1970, as amended, increasing the Penalty to \$1,000.

The Council of the Corporation of the City of Brampton, pursuant to The Planning Act, R.S.O. 1970, Chapter 349, Section 35, enacts as follows:

1. By-law number 1263, as amended by By-law 1440, as amended, of the City of Brampton (Former Town of Brampton) is hereby further amended by repealing Section 4, and inserting in lieu thereof, the following Section 4:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00), exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act."

2. By-law numbers 1390 and 1393, as amended, of the City of Brampton (Former Town of Brampton) are hereby further amended, by repealing Section 3 in each and all said By-laws, and inserting in lieu thereof, the following Section 3 in each and all said By-laws:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00), exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act."

2. By-law number 1506, as amended, of the City of Brampton (Former Town of Brampton) is hereby further amended, by repealing Section 5, and inserting in lieu thereof, the following Section 5:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00), exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act."

4. By-law number 1827, as amended, of the City of Brampton (Former Town of Brampton) is hereby further amended, by repealing Section 19, and inserting in lieu thereof, the following Section 19:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00), exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act."

5. By-law numbers 2417, 2419, 2421, 2423, 2429, 2434, 2436, 2451 and 2566, as amended of the City of Brampton (Former Town of Brampton) are hereby further amended, by repealing Section 3.2 in each and all said By-laws and inserting in lieu thereof, the following Section 3.2 in each and all said By-laws:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00), exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act."

6. By-law Number 2460, as amended, of the City of Brampton (Former Town of Brampton) is hereby further amended, by repealing Section 9.2, and inserting in lieu thereof, the following Section 9.2:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00), exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act."

7. By-law numbers 2543, 2561, 2565, 2583, 2590, 2600, 2609, 2613, 2626, 2673, 2674, 2688, 2700, 2710, 2738, 2780 and 2802, as amended, of the City of Brampton (Former Town of Brampton), are hereby further amended by repealing Section 4.2 in each and all said By-laws and inserting in lieu thereof, the following Section 4.2 in each and all said By-laws:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00), exclusive of costs for each and every such offence and every fine is recoverable under the Summary Convictions Act."

8. By-law number 861, as amended by By-law 877, as amended, of the City of Brampton (Former Township of Chinguacousy) is hereby further amended, by repealing Section 22, Sub-section 5, and inserting in lieu thereof, the following Section 22, Sub-section 5:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00), exclusive of costs for each and every such offence and every fine is recoverable under the Summary Convictions Act."

Cont'd ...

9. By-law number 5500, as amended, of the City of Brampton for that portion of the former Town of Mississauga that became part of the City of Brampton on January 1st, 1974, is hereby further amended, by repealing Section 133, and inserting in lieu thereof, the following Section 133:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00), exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act."

10. By-law number 696, as amended, of the City of Brampton (Former Township of Toronto Gore) is hereby further amended by inserting a new Section 3 as follows:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00), exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act."

11. By-law Number 808, as amended, of the City of Brampton (Former Township of Toronto Gore) is hereby further amended by repealing Section 10, Sub-section 4 and inserting in lieu thereof, the following Section 10, Sub-section 4:-


"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00), exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act."


12. By-law numbers 825 and 818, as amended, of the City of Brampton (Former Township of Toronto Gore), are hereby further amended, by repealing Section 11, Sub-section 4 in each and all said By-laws and inserting in lieu thereof, the following Section 11, Sub-section 4 in each and all said By-laws:-

"Everyyperson who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00), exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act."

This By-law shall come into force and take effect upon the final passing thereof, subject to the approval of The Ontario Municipal Board.
