The Council of the Corporation of the City of Brampton ENACTS as follows:

- 1. By-law 25-79, as amended, is hereby further amended:
 - (1) by changing on Schedule A, Sheet 11, the zoning designation of the lands shown on Schedule A to this by-law and numbered 1, from RESIDENTIAL SINGLE-FAMILY "B" (R1B) to HIGHWAY COMMERCIAL ONE SECTION 184 (HC1-SECTION 184).
 - (2) by changing on Schedule A, Sheet 11, the zoning designation of the lands shown outlined on Schedule A to this by-law and numbered 2, from HIGHWAY COMMERCIAL ONE (HC1) to HIGHWAY COMMERCIAL ONE SECTION 184 (HC1-SECTION 184).
 - (3) by adding thereto as Section 184:
 - "184. The lands designated HCl-Section 184 on Schedule A hereto attached:
 - 184.1 shall only be used for those purposes permitted in the HCl zone;
 - 184.2 shall be subject to the following restriction:

Maximum Building Height: 6 stories

184.3 shall be subject to the requirements and restrictions of the HCl Zone not in conflict with the one set out in subsection 184.2."


