1. By-law 160-92, is hereby amended as follows:
 - a) Anywhere in the by-law where the words "Fire & Emergency Services Department" are found the word "Department" shall be deleted; and
 - b) Schedule A-1 to by-law 160-92 is hereby deleted and replaced with a revised Schedule A-1 appended as Schedule I to this by-law.

Any requested or required inspection of licensed sales establishments (as defined by the Liquor License Establishment Board of Ontario) that requires a Fire Department inspection letter	\$100.00
All existing licensed sales establishments (as defined by the License Board of Ontario) with an occupancy load of 60 persons or above, that were not architecturally or engineered designed as part of a required Building Permit (to be posted on drawings)	\$100.00
