BY-LAW

Number 40-82

To authorize a capital expenditure in the amount of \$3,837,500.00 for the construction of certain works.

WHEREAS the Council of The Corporation of the City of Brampton desires to undertake the construction of certain works as set out in Schedule "A" attached hereto.

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. That the Council of The Corporation of the City of Brampton shall undertake the construction of certain works as set out in Schedule "A" attached hereto at a total estimated cost of \$3,837,500.00.
2. That the Mayor and the Treasurer are hereby authorized in the name of and on behalf of the Corporation to borrow from time to time by way of promissory note from the Royal Bank of Canada, 1 Main Street North, Brampton, a sum or sums not exceeding in the aggregate \$3,837,500.00 for the aforementioned purpose and to give on behalf of the Corporation to the Royal Bank of Canada a promissory note or notes sealed with the Corporate Seal and signed by the Mayor and the Treasurer for the money so borrowed with interest which may be paid in advance or otherwise.

READ a FIRST, SECOND and THIRD TIME and PASSED in Open Council this 22nd day of February, 1982.

Reconstruction of:

1. RUTHERFORD ROAD from 30 metres south of Davidson Road to 75 metres north of Orenda Road including widening, excavation, granular base, curb and gutter, asphalt paving, storm sewers, sidewalks, street lighting, utility relocations plus related works.
2. RUTHERFORD ROAD from 75 metres south of Clarence Street to Steeles Avenue from a two lane gravel shoulder roadway to a four lane curb and guttered section with left turn lane storage at intersecting roads including excavation, granular base, curb and gutter, asphalt paving and H.L.3 asphalt overlay storm sewers, sidewalks, street lighting, utility relocations plus related works.
3. CHURCH STREET from Main Street to Scott Street including storm sewers, excavation, granular base, concrete curb and gutter, paving, sidewalks and related works.
4. STERNE AVENUE from Eldomar Avenue to Clarence Street including storm sewers, excavation, granular base, curb and gutter, sidewalks, roadway pavement and utility relocations and related works.
5. BIRCH ROAD from Brentwood Drive to Belmont Drive.
6. BELMONT DRIVE from Birchbank Road to Birchbank Road.
7. BROOKLAND CRESCENT from Belmont Drive to Belmont Drive.
8. MOORE STREET from 35 metres north of Reeve Road to Archibald Street
9. ROGERS ROAD from Moore Street to Archibald Street.
10. JESSIE STREET from Haggart Avenue to 120 metres westerly.
11. LYNFIELD COURT from Eldomar Avenue to end of court.
12. KENNEDY ROAD from Steeles Avenue to the South City limits, including drainage works, excavation, grading granular base, paving, street lighting and related works.

MISCELLANEOUS TRAFFIC SIGNALS as follows:

13. Rutherford Road/Orenda Road
14. Rutherford Road/Clarence Street
15. Williams Parkway/MacKay Street

INTERSECTION IMPROVEMENTS at the following locations:

16. Queen Street/Kennedy Road westbound to northbound right hand turn lane.
17. Bramalea Road/Clark Boulevard left turn lanes on Clark Boulevard.
18. Queen Street/Rutherford Road eastbound to westbound right hand turn lanes on Queen Street.
19. Queen Street/Hansen Road westbound right hand turn lane on Queen Street.
20. Reconstruction of Elmgrove Avenue from Fairglen Avenue to Pleasantview Avenue.
