WHEREAS the owner of land in the west half of Lot 16, Concession 4, W.H.S. formerly in the Township of Chinguacousy, now in the City of Brampton, has applied to the Council under <u>The Tile Drainage Act, 1971</u> for a loan for the purpose of constructing sub-surface drainage works on such land;

AND WHEREAS the Council has upon the application of Mr. James L. Clark, lent him the total sum of \$14,000.00, to be repaid with interest by means of a rate hereinafter imposed, being an annual rate of \$2,086.00 for 10 years;

NOW THEREFORE the Council of The Corporation of the City of Brampton hereby ENACTS as follows:

- 1. The annual rate set out in Schedule A attached hereto is hereby imposed upon such land as described for a period of ten years, commencing in the year 1981, such rate to be levied and collected in the same manner as taxes.
- 2. By-law Number 38-81 is hereby repealed.
