To further amend By-law 193-83 (the regulation of traffic),  
as amended for the placement of an ALL WAY STOP on  
Charolais Boulevard and Moffatt Avenue/Torrance Woods  
(easterly intersection)

The council of the Corporation of the City of Brampton hereby  
ENACTS as follows:

i. By-law 193-83, as amended, is hereby further amended:

(1) by deleting from the specified columns of Schedule VIII  
thereto the following item:

THROUGH HIGHWAYS

<u>COLUMN 1</u> <u>HIGHWAY</u>	<u>COLUMN 2</u> <u>BETWEEN</u>
Charolais Boulevard	The east limit of Chinguacousy Road and the west limit of Main Street South

(2) by adding to the specified columns of Schedule VIII  
thereto the following item:

THROUGH HIGHWAYS

<u>COLUMN 1</u> <u>HIGHWAY</u>	<u>COLUMN 2</u> <u>BETWEEN</u>
Charolais Boulevard	The east limit of Chinguacousy Road and the west limit of Moffatt Avenue/ Torrance Woods (easterly intersection)
Charolais Boulevard	The east limit of Moffatt Avenue/ Torrance Woods (easterly intersection) and the west limit of Main Street South

- (4) by adding to the specified columns of Schedule IX thereto the following items:

STOP SIGNS

COLUMN 1  
INTERSECTION

Charolais Boulevard and Moffatt Avenue/Torrance Woods (easterly intersection)

COLUMN 2  
FACING TRAFFIC

Northbound on Moffatt Avenue

Southbound on Torrance Woods



Westbound on Charolais Boulevard

Eastbound on Charolais Boulevard

1. By-Law 195-B3, as amended, is hereby further amended:

(1) by deleting from the specified columns of Schedule VIII  
thereto the following item:

## THROUGH HIGHWAYS

COLUMN 1 <u>HIGHWAY</u>	COLUMN 2 <u>BETWEEN</u>
Charolais Boulevard	the east limit of Chinquacousy Road and the west limit of Main Street South

(2) by adding to the specified columns of Schedule VIII  
thereto the following items:

## THROUGH HIGHWAYS

COLUMN 1 <u>HIGHWAY</u>	COLUMN 2 <u>BETWEEN</u>
Charolais Boulevard	the east limit of Chinquacousy Road and the west limit of Moffatt Avenue/ Torrence Woods (easterly intersection)
Charolais Boulevard	the east limit of Moffatt Avenue/ Torrence Woods (easterly intersection) and the west limit of Main Street South

74) by adding to the existing outcome of Schedule I  
the following additional item:

**STREETS**

<b>COLUMN 1 INTERSECTION</b>	<b>COLUMN 2 FALLING ROAD</b>
Cherolais Boulevard and Moffatt Avenue/Torrence Woods (eastern intersection)	Northbound on Moffatt Avenue
Cherolais Boulevard and Moffatt Avenue/Torrence Woods (western intersection)	Southbound on Torrence Woods
Cherolais Boulevard and Moffatt Avenue/Torrence Woods (western intersection)	Westbound on Cherolais Boulevard
Cherolais Boulevard and Moffatt Avenue/Torrence Woods (eastern intersection)	Eastbound on Chardine Boulevard
