WHEREAS it is deemed expedient to establish certain lands as part of the public highway system.

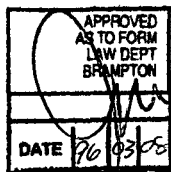
NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:
