



THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 55-77


To amend By-law Number 861 as amended by By-law Number 877 as amended of the former Township of Chinguacousy to re-zone the lands shown on Schedule "A" hereto attached from "A1" to "R4", "R4S" and "G" Zones.

The Municipal Council of the Corporation of the City of Brampton ENACTS as follows:

1. In the R4S zone, the following regulation shall apply to those lands shown on Schedule "A" hereto attached:
 - (i) Minimum Front Yard - 20 feet provided that the front of any garage shall not be closer than 23 feet to the front lot line.
2. Schedule "A" to said By-law Number 861 as amended by By-law Number 877 as amended, is hereby further amended by changing the zone designation and boundaries thereof shown on Schedule "A" to said By-law Number 861 as amended by By-law Number 877 as amended, from the designation "~~A1~~" to the zone designations shown for the lands on Schedule "A" attached hereto.
3. Schedule "B" to said By-law Number 861 as amended by By-law Number 877 as amended, is hereby further amended by including therein the lands shown on Schedule "A" attached hereto designated by the zones shown on Schedule "A" hereto. The said Schedule "B" is therefore further amended by the deletion of the lands shown on Schedule "A" hereto from the designation of the said lands as "A1" in said By-law Number 861 as amended by By-law Number 877 as amended.
4. Schedule "A" attached hereto forms part of this By-law.
5. This By-law shall not come into force or effect unless and until approved by the Ontario Municipal Board.

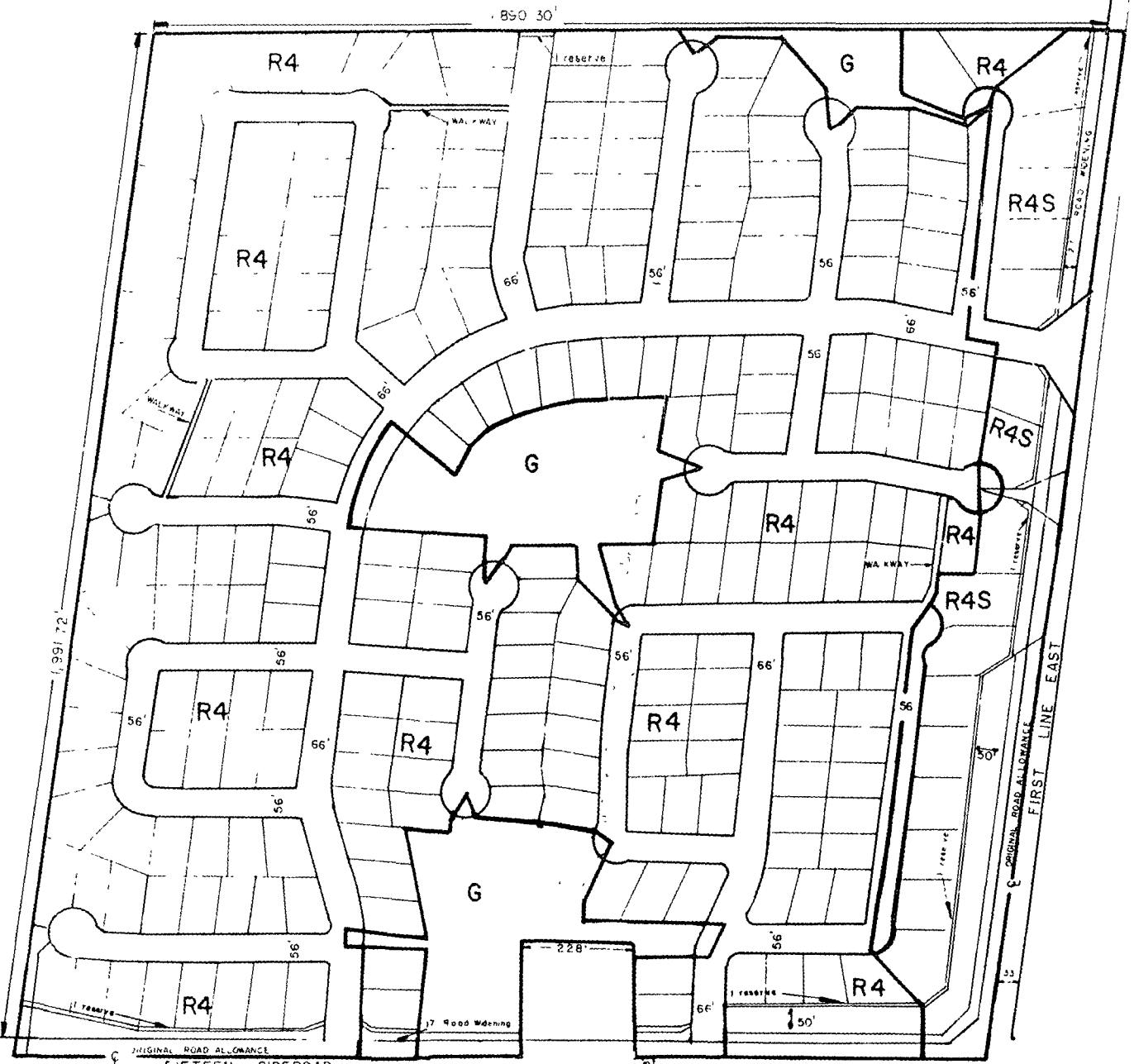

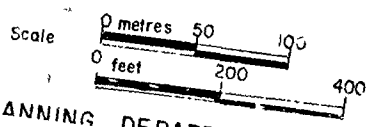

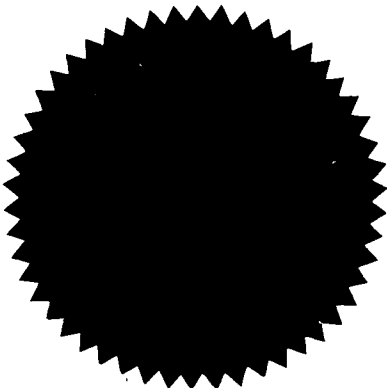
