- 1. By-law 193-83, as amended, is hereby further amended:
 - (1) by deleting from the specified columns of Schedule XVI thereto the following item:

COLUMN 1	COLUMN 2	COLUMN 3
<u>HIGHWAY</u>	RATE OF SPEED	BETWEEN
Creditview Road	70	A point 450 metres south of Queen Street West and a point 1,290 metres south of Queen Street West
