AMENDMENT NUMBER <u>261</u> TO THE 1984 OFFICIAL PLAN OF THE CITY OF BRAMPTON PLANNING AREA

1.0 <u>PURPOSE</u>

The purpose of this amendment is to recognize and permit the westward relocation of the Creditview Road "Collector Road" designation in the area between Steeles Avenue and the southerly City of Brampton boundary, including the corresponding westward relocation of the Highway 407 bridge crossing to a new alignment approximately in the middle of Concession 4 and connecting to Financial Drive extension in the City of Mississauga. Existing Creditview Road would therefore be maintained as a local road and be closed at Highway 407.


2.0 LOCATION

Existing Creditview Road generally separates Concessions 3 and 4 W.H.S. of the former Township of Chinguacousy. The section of Creditview Road which is affected by this amendment is between Steeles Avenue and the southerly City of Brampton boundary. The properties significantly affected by the proposed Collector Road alignment are located in the area south of Steeles Avenue and north of the southerly City of Brampton boundary, and between Mississauga Road and the Canadian Pacific Railway line.

3.0 AMENDMENTS AND POLICIES RELATIVE THERETO

The document known as the 1984 Official Plan of the City of Brampton Planning Area is hereby amended:

- (1) by deleting on Schedule "H" <u>Major Transportation Elements and Major Road</u> <u>Network</u> thereto, existing Creditview Road and Churchville Road between Steeles Avenue and the southerly City of Brampton boundary, as collector roads, and the corresponding grade separation over Highway 407, as shown on Schedule A to this Amendment;
- (2) by adding to Schedule "H" <u>Major Transportation Elements and Major Road</u> <u>Network</u> thereto, a mid-concession collector road between Steeles Avenue and the southerly City of Brampton boundary (to connect to Financial Drive extension in the City of Mississauga) and a corresponding grade separation over Highway 407, as shown on Schedule A to this amendment;
- (3) by deleting on Schedule "I" <u>Major Road Right-of-Way Widths</u> thereto, existing Creditview Road and Churchville Road, between Steeles Avenue and the southerly City of Brampton boundary, as 23 to 26 metres collector roads, as shown on Schedule "B" to this Amendment; and
- (4) by adding to Schedule "I" <u>Major Road Right-of-Way Widths</u> thereto, a midconcession collector road with a 30 metre right-of-way width, as shown on Schedule B to this amendment.
