To amend By-law 151-88 as amended (part of Lot 11, Concession 2, E.H.S., in the geographic Township of Chinguacousy)

The Council of The Corporation of the City of Brampton ENACTS as follows:

- 1. By-law 151-88, as amended, is hereby further amended:
 - (1) by changing on Sheet 26F of Schedule 'A' thereto, the zoning designations of the lands shown outlined on Schedule 'A' to this by-law from AGRICULTURAL (A) to RESIDENTIAL SINGLE FAMILY D (R1D) - SECTION 358 (R1D-SECTION 358), such lands being part of Lot 11, Concession 2, East of Hurontario Street, in the geographic Township of Chinguacousy.


