BY-LAW

Number 68-86

To amend By-law 139-84
(part of Lot 15, Concession
1, W.H.S., geographic
Township of Toronto)

The council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 139-84, as amended, is hereby further amended:

(1) by changing the zoning designation of the lands shown outlined on Schedule A to this by-law from INSTITUTIONAL TWO - SECTION 557 (I2 - SECTION 557) to INSTITUTIONAL TWO - SECTION 622 (I2 - SECTION 622).

(2) by adding thereto the following section:

"622 The lands designated I2 - SECTION 622 on Schedule A to this by-law:

622.1 shall only be used for:

- (1) a community college,
- (2) only in conjunction with a community college, a day nursery,
- (3) a public or private school, and
- (4) purposes accessory to the other permitted purposes.

622.2 shall be subject to the requirements and restrictions relating to the I2 zone."

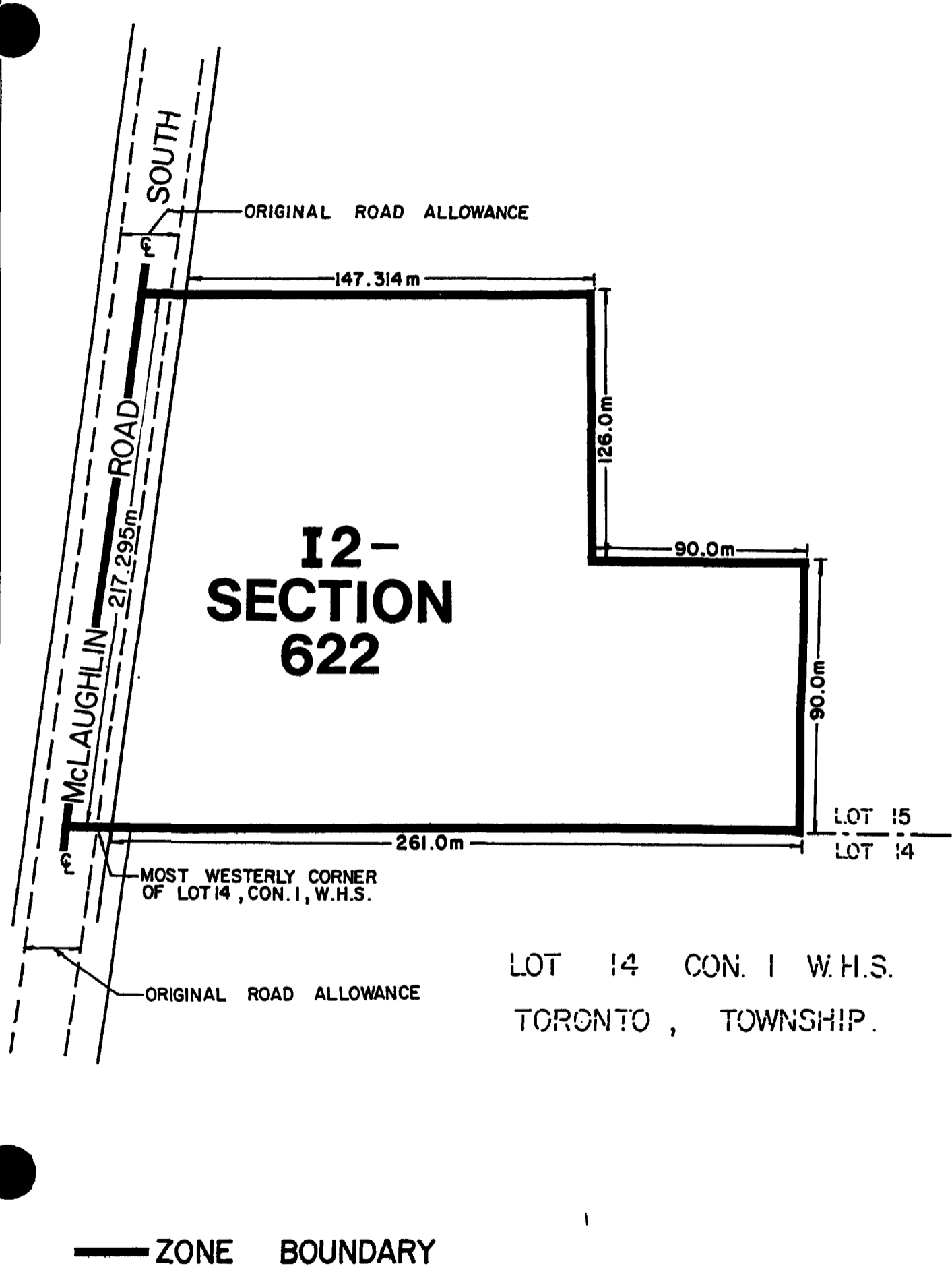

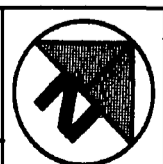


