To amend By-law 56-83 (part of Lot 7, Concession 8, N.D., in the geographic Township of Toronto Gore)

The council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 56-83, as amended, is hereby further amended:

(1) by changing, on Sheet 14 of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by-law from RESIDENTIAL ESTATE HOLDING (REH) to RESIDENTIAL ESTATE TWO - SECTION 556 (RE2 - SECTION 556), being part of Lot 7, Concession 8, Northern Division, in the geographic Township of Toronto Gore.

(2) by adding thereto the following section:

- "556 The lands designated RE2 SECTION 556 on Sheet 14 of Schedule A to this by-law:
 - 556.1 shall only be used for the purposes permitted by section 11.2.1
 - 556.2 shall be subject to the following requirements and restrictions:
 - (1) minimum lot width: 68 metres
 - (2) minimum lot area:

(a) for Lot A = 0.55 hectare (b) for Lot B = 0.57 hectare 556.3 shall also be subject to the requirements and restrictions relating to the RE2 zone and all the general provisions of this by-law which are not in conflict with the ones set out in section 556.2."


