



THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW

Number 70-88

To amend By-law 200-82 (part of Lot 7, Concession 1, E.H.S., in the geographic Township of Chinguacousy)

The council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 200-82, as amended, is hereby further amended:

(1) by changing on sheet 9 of Schedule A thereto, the zoning designation of the land shown outlined on Schedule A to this by-law from OPEN SPACE (OS) to INSTITUTIONAL TWO-SECTION 292 (I2-SECTION 292), such lands being part of Lot 7, Concession 1, east of Hurontario Street, in the geographic Township of Chinguacousy.

(2) by adding thereto the following section:

"292 The lands designated I2 - Section 292 on Sheet 9 of Schedule A to this by-law:

292.1 shall only be used for the following purposes:

(1) purposes permitted by section 40.2.1(c)

(2) a fire station

(3) a combined fire station and recreation facility

(4) proposes accessory to the other permitted purposes

292.2 shall be subject to the following requirements and restrictions:

- (1) Minimum front yard depth - 10 metres
- (2) Minimum rear yard - 20 metres
- (3) Minimum side yard width
 - a) east side - 7.5 metres
 - b) west side - 15.0 metres.

292.3 shall also be subject to the requirements and restrictions relating to the I2 zone, and all the general provisions of this by-law, which are not in conflict with the ones set out in section 292.2."

READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL,

this 21st day of March 1988.

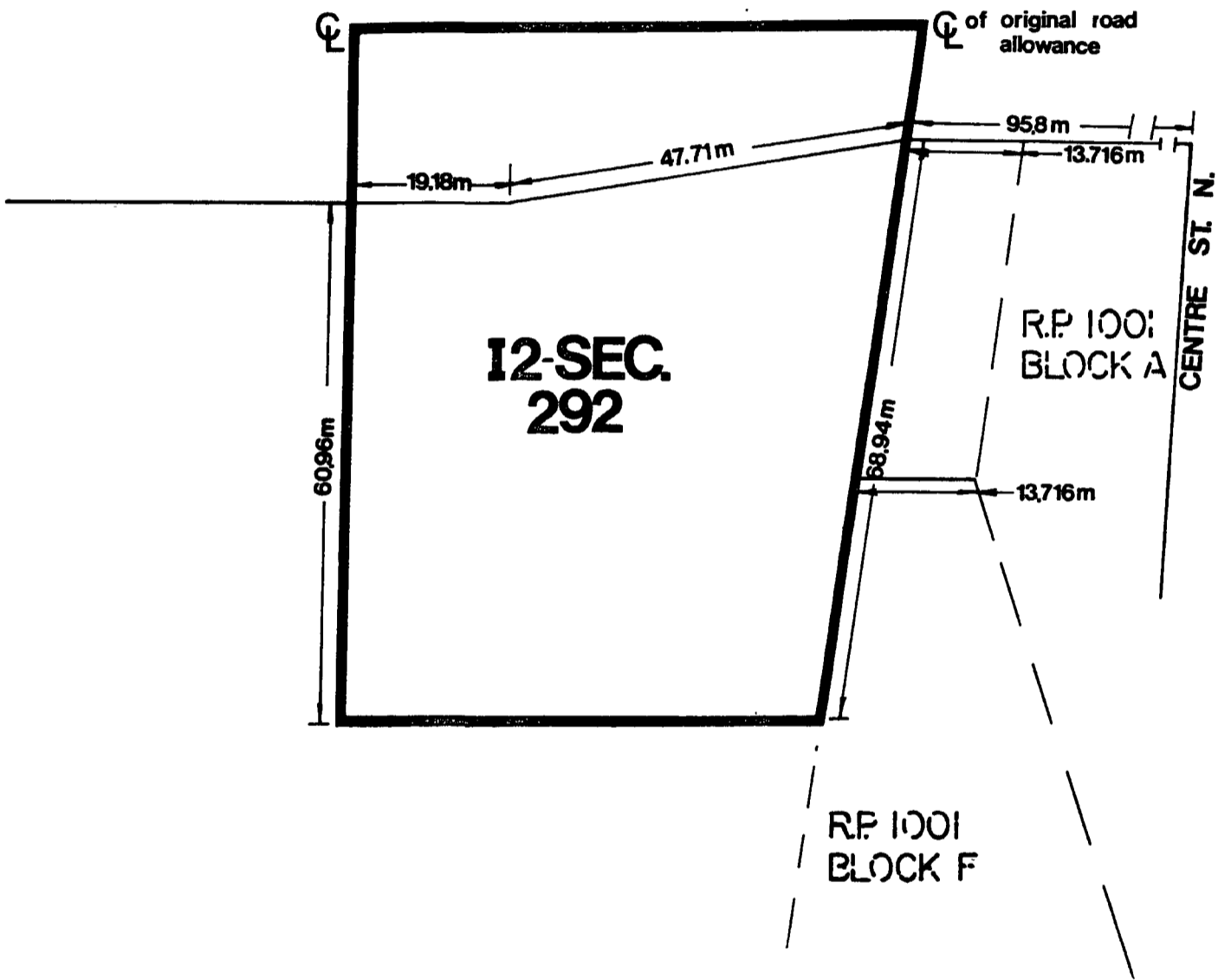
