

## THE CORPORATION OF THE CITY OF BRAMPTON

## **BY-LAW**

A By-law to amend the penalty provisions of certain by-laws and to provide that either a Justice of the Peace or Provincial Court Judge has jurisdiction to hear and determine prosecutions under City of Brampton By-laws.

The Council of The Corporation of the City of Brampton enacts as follows:

- 1. Except for By-laws which expressly refer to "Magistrate" or "Judge", the Corporation of the City of Brampton hereby authorizes a Justice of the Peace to hear and determine prosecutions under all By-laws enacted by the Council of the Corporation of the City of Brampton.
- 2. By-law number 1263, as amended by By-law 1440, as amended, of the former Town of Brampton now the City of Brampton, is hereby further amended by repealing Section 4, and inserting in lieu thereof, the following Section 4:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00), exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act. A Provincial Court Judge or a Justice of the Peace are hereby authorized to hear and determine prosecutions under this By-law."

3. By-law numbers 1390 and 1393, as amended, of the former Town of Brampton now the City of Brampton, are hereby further amended, by repealing Section 3 in each and all said By-laws, and inserting in lieu thereof, the following Section 3 in each and all said By-laws:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00) exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act. A Provincial Court Judge or a Justice of the Peace are hereby authorized to hear and determine prosecutions under this By-law."

4. By-law number 1506, as amended, of the former Town of Brampton, now the City of Brampton, is hereby further amended, by repealing Section 5, and inserting in lieu thereof, the following Section 5:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00), exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act. A Provincial Court Judge or a Justice of the Peace are hereby authorized to hear and determine prosecutions under this By-law."

5. By-law number 1827, as amended, of the former Town of Brampton now the City of Brampton, is hereby further amended, by repealing Section 19, and inserting in lieu thereof, the following Section 19:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00), exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act. A Provincial Court Judge or a Justice of the Peace are hereby authorized to hear and determine prosecutions under this By-law."

6. By-law numbers 2417, 2419, 2421, 2423, 2429, 2434, 2436, 2451 and 2566, as amended of the former Town of Brampton now the City of Brampton, are hereby further amended, by repealing Section 3.2 in each and all said By-laws and inserting in lieu thereof, the following Section 3.2 in each and all said By-laws:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00) exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act. A Provincial Court Judge or a Justice of the Peace are hereby authorized to hear and determine prosecutions under this By-law."

7. By-law number 2460, as amended, of the former Town of Brampton now the City of Brampton, is hereby further amended by repealing Section 9.2, and inserting in lieu thereof, the following Section 9.2:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00), exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act. A Provincial Court Judge or a Justice of the Peace are hereby authorized to hear and determine prosecutions under this By-law."

8. By-law numbers 2543, 2561, 2565, 2583, 2590, 2600, 2609, 2613, 2626, 2673, 2674, 2688, 2700, 2710, 2738, 2780 and 2802, as amended, of the former Town of Brampton now the City of Brampton, are hereby further amended by repealing Section 4.2 in each and all said By-laws and inserting in lieu thereof, the following Section 4.2 in each and all said By-laws:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00) exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act. A Provincial Court Judge or a Justice of the Peace are hereby authorized to hear and determine prosecutions under this By-law."

9. By-law number 861, as amended by By-law 877, as amended, of the former Township of Chinguacousy now the City of Brampton, is hereby further amended by repealing Section 22, Sub-section 5 and inserting in lieu thereof, the following Section 22, Sub-section 5:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00) exclusive of costs for each and every such offence and every fine is recoverable under the Summary Convictions Act. A Provincial Court Judge or a Justice of the Peace are hereby authorized to hear and determine prosecutions under this By-law."

10. By-law number 5500, as amended of the City of Brampton for that portion of the former Town of Mississauga that became part of the City of Brampton on January 1st, 1974, is hereby further amended, by repealing Section 133, and inserting in lieu thereof, the following Section 133:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00) exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act. A Provincial Court Judge or a Justice of the Peace are hereby authorized to hear and determine prosecutions under this By-law."

11. By-law number 696, as amended, of the former Township of Toronto Gore, now the City of Brampton, is hereby further amended by inserting a new Section 3 as follows:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00) exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act. A Provincial Court Judge or Justice of the Peace are hereby authorized to hear and determine prosecutions under this By-law."

12. By-law number 808, as amended, of the former Township of Toronto Gore now the City of Brampton, is hereby further amended by repealing Section 10, Sub-section 4 and inserting in lieu thereof, the following Section 10, Sub-section 4:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00) exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act. A Provincial Court Judge or Justice of the Peace are hereby authorized to hear and determine prosecutions under this By-law."

13. By-law numbers 825 and 818, as amended, of the former Township of Toronto Gore now the City of Brampton, are hereby further amended, by repealing Section 11, Subsection 4 in each and all said By-laws and inserting in lieu thereof, the following Section 11, Subsection 4 in each and all said By-laws:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00) exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act. A Provincial Court Judge or Justice of the Peace are hereby authorized to hear and determine prosecutions under this By-law."

14. Section 11 of By-law 35-74 is hereby repealed and the following substituted therefore:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to appenalty not exceeding One Thousand Dollars (\$1,000.00) exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act. A Provincial Court Judge or Justice of the Peace are hereby authorized to hear and determine prosecutions under this By-law."

15. Section 14 of By-law 60-74 is hereby repealed and the following substituted therefore:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00) exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act. A Provincial Court Judge or Justice of the Peace are hereby authorized to hear and determine prosecutions under this By-law."

16. Section 5 of By-law 61-74 is hereby repealed and the following substituted therefore:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00) exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act. A Provincial Court Judge or a Justice of the Peace are hereby authorized to hear and determine prosecutions under this By-law."

17. Section 5 of By-law 15-75 is hereby repealed and the following substituted therefore:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00) exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act. A Provincial Court Judge or a Justice of the Peace are hereby authorized to hear and determine prosecutions under this By-law."

18. Section 6 of By-law 22-75 is hereby repealed and the following substituted therefore:

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00) exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act. A Provincial Court Judge or a Justice of the Peace are hereby authorized to hear and determine prosecutions under this By-law."

19. Section 4 of By-law 107-75 is hereby repealed and the following substituted therefore:-

"Every person who contravenes this By-law is guilty of an offence and liable upon summary conviction to a penalty not exceeding One Thousand Dollars (\$1,000.00) exclusive of costs for each and every such offence and every fine is recoverable under The Summary Convictions Act. A Provincial Court Judge or a Justice of the Peace are hereby authorized to hear and determine prosecutions under this By-law."

This By-law shall come into force and take effect upon the final passing thereof, subject to any necessary approval of the Ontario Municipal Board.


