THE CORPORATION OF THE CITY OF BRAMPTON

BY-LAW NUMBER 72-75

To establish, maintain and regulate a Public Market.

WHEREAS sections 364 and 365 of the Municipal Act R.S.O. 1970, chapter 284, as amended, provides that Councils of urban municipalities may pass by-laws for establishing, maintaining and regulating markets,

AND WHEREAS, the Council of the City of Brampton deems it expedient and advisable that a market be established in the City of Brampton.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE CITY OF BRAMPTON HEREBY ENACTS AS FOLLOWS:-

- (1) That the area known as the George Street South Municipal Parking Lot, be established as a Farmers' Market on each Saturday during the months of May to October, both inclusive.
- (2) That the Brampton Board of Trade be and are hereby authorized to operate the market for and on behalf of the City of Brampton.
- (3) That the parking meters on the west side of Main Street South, between Queen Street and Wellington Street shall be hooded during the period of the Farmers' Market, to facilitate the loading and unloading of vendors at the market, and appropriate signs be erected indicating loading areas.
- (4) The Engineering Department be authorized to make renovations to the guard rails and certain internal alterations to the parking lot to facilitate better accommodation for the vendors.
- (5) The Brampton Board of Trade be authorized to erect a banner across Main Street South advertising the market, subject to the approval of the Brampton Hydro and the City Engineer. All directional signs which the operators of the market wish to erect shall be subject to the approval of the City Engineer and shall conform to the Signs By-law Regulations.
- (6) Should electrical outlets be required, same will be installed at the expense of the Brampton Board of Trade subject to the approval of the City Engineer and the Brampton Hydro.
- (7) The Brampton Farmers' Market shall comply with the applicable regulations of the Regional Board of Health.
- (8) The Brampton Board of Trade or the operators of the market shall clean up the George Street South Municipal Parking Lot to the satisfaction of the City Engineer, during and following each day of use.
- (9) That the Brampton Board of Trade shall file with the City, a copy of all regulations that are established relating to the operation and functions of the market.
- (10) That the Brampton Board of Trade shall pay to the City annually, a fee of \$50.00 in lieu of the City Licencing individual vendors of the market.

(11) That the Brampton Board of Trade shall file with the City, by May 15th, a copy of its Liability Insurance Policy in the amount of \$500,000.00 holding the City of Brampton harmless for any incident that may occur at or during the period of the Farmers' Market.

READ A FIRST, SECOND AND THIRD TIME and finally passed in Open Council this 21st, day of April, 1975.
