1. By-law 56-83, as amended, is hereby further amended:
  - (1) by changing, on Sheet 14 of Schedule A thereto, the zoning designation of the lands shown outlined on Schedule A to this by-law from RESIDENTIAL SINGLE DETACHED C - SECTION 803 (R1C - SECTION 803) to RESIDENTIAL SINGLE DETACHED C - SECTION 820 (R1C - SECTION 820).


READ a FIRST, SECOND and THIRD TIME, and PASSED in OPEN COUNCIL,  
this 8<sup>th</sup> day of march 2004.

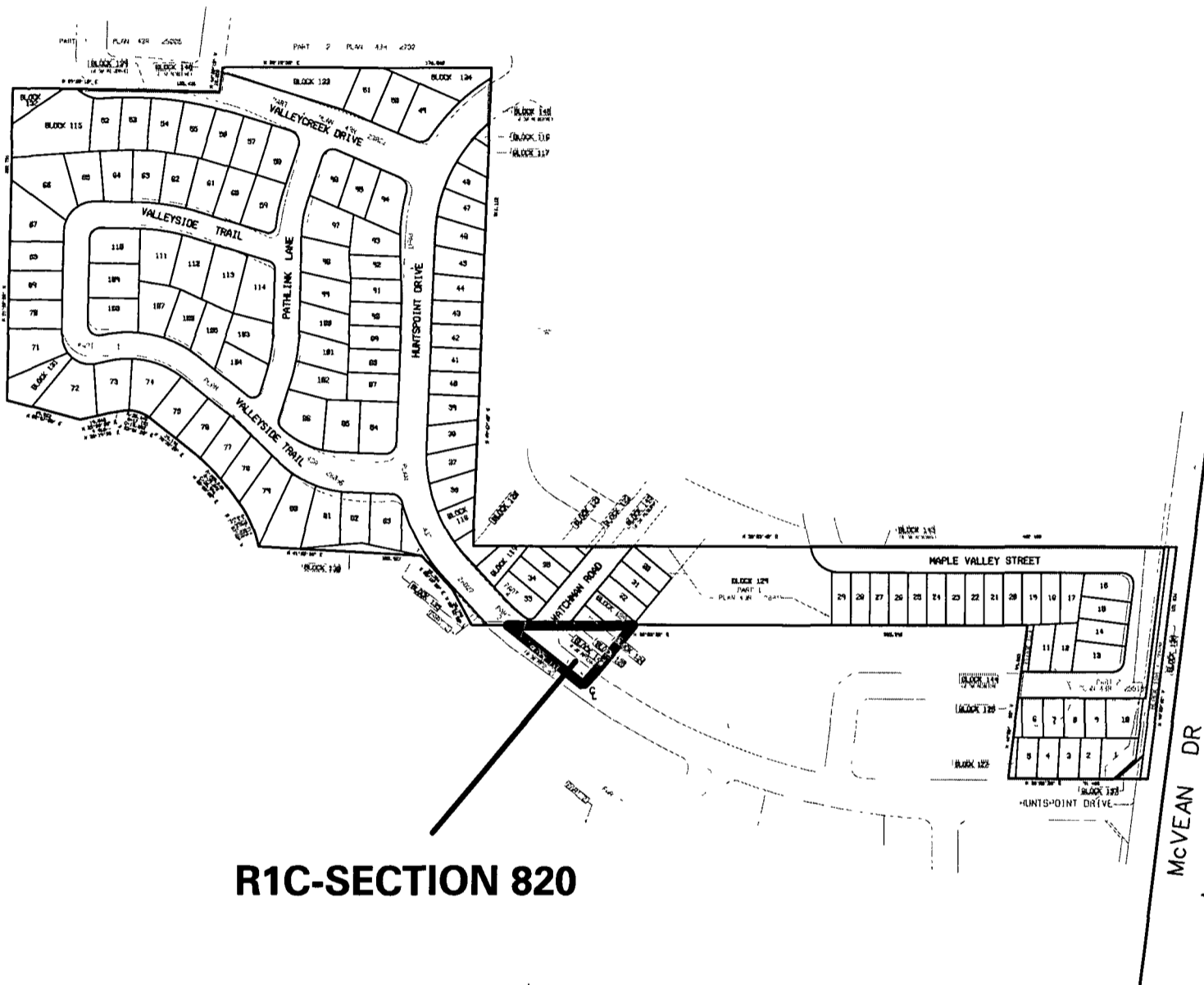

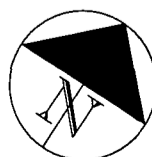
