### **BY-LAW**

A By-law to amend By-law 825 of the former Township of Toronto Gore as it pertains to part of Lots 11 and 12, Concession 8, Northern Division, in the former Township of Toronto Gore, now in the City of Brampton.

The Council of the Corporation of the City of Brampton hereby ENACTS as follows:

- 1. Schedule A of By-law 825 as amended, being the Restricted Area By-law of the Former Township of Toronto Gore, is hereby further amended by changing the zoning designation of the lands shown outlined on Schedule A attached to this By-law from AGRICULTURAL (A) to ESTATE RESIDENTIAL (ER), FLOODPLAIN (F) and GREENBELT-SECTION 52 (G-SECTION 52), such lands being part of Lots 11 and 12, Concession 8, Northern Division, of the former Township of Toronto Gore, now in the City of Brampton.
- 2. Schedule A of this By-law is hereby attached to By-law 825 as part of Schedule A, and forms part of By-law 825.
- 3. This By-law shall not come into force without the approval of the Ontario Municipal Board.




