Number 77-77 A By-law to amend By-law Number 7-76 of the City of Brampton to prohibit or regulate the use of land and the erection, use, bulk, height and location of buildings located in Part of Lot I, Concession I, E.H.S., being Lot 42, Railway Block, Plan BR-5, City of Brampton, Region of Peel.

The Council of the Corporation of the City of Brampton ENACTS as follows:

Section 2.0, Subsection 2.2 - Permitted Uses is hereby amended by the 1. deletion of said subsection and its replacement with the following:

2.2 Permitted Uses

2.2.1 Ground Floor Only

- (a) medical offices
- (b) lawyer
- (c) accountant
- (d) engineer
- (e) travel agency
- (f) insurance agency
- (g) real estate broker
 - (h) finance office
 - (i) personnel office
 - (j) optician

2.2.2 Second Floor Only

- (a) medical offices
- 2.

Section 3.0 - Regulations Subsection 3.3 (b) is hereby amended by the deletion of said subsection and its replacement with the following:

> (b) The permitted building may contain not more than three (3) medical offices should the building be occupied by medical uses only.

This By-law shall not come into force or effect unless and until approved by 3. the Ontario Municipal Board.


