# BY-LAW

Number 78-2007

A By-law to amend Fee By-law 380-2003,  
as amended

WHEREAS By-law 380-2003 was passed pursuant to the *Municipal Act, 2001*, S.O. 2001, c. 25, s.391(1) to impose fees or charges;

AND WHEREAS, pursuant to Committee of Council Recommendations CWB18-2007 and CWB20-2007, approved by City Council on March 21, 2007, it is deemed appropriate to amend Fee By-law 380-2003;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS as follows:

1. That Schedule H to By-law 380-2003 is hereby amended as follows:

Downtown Lots (City Hall, Nelson Square, Market Square)  
(inclusive of all taxes)

Monthly	\$40.00
\$ per ½ hour	\$0.75
Daily Flat Rate (maximum)	\$8.00
Annual	\$280.00
Annual Specialty	\$840.00

Outdoor Surface Lots (George Street, Legion, YMCA Reserved  
Parking Areas) (inclusive of all taxes)

Monthly	\$20.00
Annual	\$140.00

Parking Meters (inclusive of all taxes)

\$ per ½ hour (minimum)	\$0.50
\$ per ½ hour (maximum)	\$0.75

2. That Schedule A (Section F) to By-law 380-2003 is hereby amended as follows:

PV 9 Holes (Peel Village) – Peel Village Green Fees - \$25.00

3. That Schedule D (Animal Services) is deleted and Schedule A to this by-law substituted.


4. That Schedule I to By-law 380-2003 is hereby amended as follows:

Overdue Tax Notification Fee - \$5.00 (effective May 1, 2007)




