- (c) The rear yard shall be not less than twenty-five (25) feet in depth except that: The rear yard may be occupied by a portion of a main building located not less than twenty (20) feet from the rear lot line provided that the main building does not occupy more than fifty-five (55) per cent of the rear yard width and that at least thirty-five (35) per cent of the rear yard area is amintained in one contiguous unit with a depth of at least twenty-five (25) feet.

6. This by-law shall not come into force and take effect until and unless approved by the Ontario Municipal Board.







