# BY-LAW

Number 83-2008

To amend Traffic By-law 93-93  
by amending schedules relating to RATE OF SPEED, FIRE ROUTES, STOP  
SIGNS, NO PARKING, NO STOPPING

The Council of the Corporation of the City of Brampton ENACTS as follows:

1. By-law 93-93 is amended as follows:

(1) by adding to Schedule X the following items:

### RATE OF SPEED

COLUMN 1 HIGHWAY	COLUMN 2 RATE OF SPEED	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Leagate Street	40	McCrimmon Drive and a point 25 metres south of Luella Crescent (southerly intersection)	Anytime

(2) by adding to Schedule XXII the following items:

### FIRE ROUTES

COLUMN 1 LOCATION CODE	COLUMN 2 LOCATION
B-59 (J4)	64 Bramalea Road
C-61 (D3)	9775 Creditview Road
H-36 (H4)	40 B Hansen Road South

(3) by adding to Schedule IV the following items:

### STOP SIGNS

COLUMN 1 INTERSECTION	COLUMN 2 FACING TRAFFIC
Creditview Road/Georgian Road and James Potter Road	Southbound on Georgian Road
Creditview Road/Georgian Road and James Potter Road	Northbound on Creditview Road
Creditview Road/Georgian Road and James Potter Road	Westbound on James Potter Road
Creditview Road/Georgian Road and James Potter Road	Eastbound on James Potter Road

(4) by adding to Schedule XIV the following items:

**NO PARKING**

COLUMN 1 HIGHWAY	COLUMN 2 SIDE	COLUMN 3 BETWEEN	COLUMN 4 TIMES OR DAYS
Kennedy Road	East	Steeles Avenue East and the southerly limit of the City of Brampton	Anytime
Kennedy Road	West	First Gulf Boulevard and the southerly limit of the City of Brampton	Anytime

(5) by deleting from Schedule XIV the following items:

**NO PARKING**




(6) by adding to Schedule XV the following items:
