**WHEREAS** it is deemed expedient to establish certain lands as part of the public highway system.


**NOW THEREFORE** the Council of The Corporation of the City of Brampton **ENACTS AS FOLLOWS:**

1. The lands acquired by The Corporation of the City of Brampton and described as Part of Lot 3, Concession 3 West of Hurontario Street, Designated as Parts 73, 74, 84, 85, 87, 88, 90, 91, 96, 97, 102, 103 and 108 on Plan 43R-34485 are hereby established as part of the public highway system to be part of James Potter Road.
2. The lands acquired by The Corporation of the City of Brampton and described as Part of Lot 4, Concession 3 West of Hurontario Street, Designated as Parts 38, 43, 44, 45 and 46 on Plan 43R-34485 are hereby established as part of the public highway system to be part of James Potter Road.
3. The lands acquired by The Corporation of the City of Brampton and described as Part of Lot 5, Concession 3 West of Hurontario Street, Designated as Parts 3, 4, 22 and 23 on Plan 43R-34485 are hereby established as part of the public highway system to be part of James Potter Road.
4. The lands acquired by The Corporation of the City of Brampton and described as Part of Lot 4, Concession 3 West of Hurontario Street, Designated as Parts 35, 36, 40, 41, 52, 53, 65, 66, 152, 153, 156 and 157 on Plan 43R-34485 are hereby established as part of the public highway system to be part of Bonnie Braes Drive.
5. *The lands acquired by The Corporation of the City of Brampton and described as Part of Lot 5, Concession 3 West of Hurontario Street, Designated as Parts 6, 7, 9 and 10 on Plan 43R-34485 are hereby established as part of the public highway system to be part of Beechmont Drive.*
6. The lands acquired by The Corporation of the City of Brampton and described as Part of Lot 5, Concession 3 West of Hurontario Street, Designated as Parts 15 and 16 on Plan 43R-34485 are hereby established as part of the public highway system to be part of Libby Road.



The lands acquired by The Corporation of the City of Brampton and described as Part of Lot 4, Concession 3 West of Hurontario Street, Designated as Parts 57, 58, 68, 69, 131, 132 and 151 on Plan 43R-34485 are hereby established as part of the public highway system to be part of Lloyd Sanderson Drive.
9. The lands acquired by The Corporation of the City of Brampton and described as Part of Lot 3, Concession 3 West of Hurontario Street, Designated as Part 124 on Plan 43R-34485 is hereby established as part of the public highway system to be part of Berkwood Hollow Court.
