# BY-LAW

Number 90-92

To amend By-law 200-82, (Part of Lot 5, Concession 1, E.H.S., in the geographic Township of Chinguacousy)

The council of The Corporation of the City of Brampton ENACTS as follows:

1. By-law 200-82, as amended, is hereby further amended:

(1) by changing, on Sheet 26 of Schedule 'A' thereto, the zoning designation of the land shown outlined on Schedule A to this by-law from RESIDENTIAL SINGLE - FAMILY B ZONE (R1B) to INSTITUTIONAL TWO - SECTION 301 (I2-SECTION 301), such lands being part of Lot 5, Concession 1, East of Hurontario Street, in the geographic Township of Chinguacousy;

(2) by adding thereto, the following section:

"301 The lands designated I2-SECTION 301 on Sheet 26 of Schedule A to this by-law:

301.1 shall only be used for purposes of a parking lot in conjunction with a library.

301.2 shall be subject to the following requirements and restrictions:


(1) a maximum of 26 parking spaces shall be provided, and

(2) all parking spaces shall be oriented perpendicular towards the east property boundary.

301.3 shall also be subject to the requirements and restrictions relating to the I2 zone and all the general provisions of this by-law which are not in conflict with the ones set out in section 301.2"


READ a FIRST, SECOND and THIRD TIME, and PASSED, in OPEN COUNCIL, this 11th day of May 1992 .




DECLARATION
