AND WHEREAS it is deemed expedient to accept and assume the streets on Registered Plans 43M-1439 and 43M-1472 as part of the public highway system.

NOW THEREFORE the Council of The Corporation of the City of Brampton hereby **ENACTS** as follows:

- 1. All of the works constructed and installed in accordance with the subdivision agreement for Registered Plans 43M-1439 and 43M-1472 are hereby accepted and assumed.
- 2. The lands described in Schedule A to this by-law are hereby accepted and assumed as part of the public highway system of the City of Brampton.


