To change the name of Larkspur Road West of Bramalea Road

The Council of The Corporation of the City of Brampton deems it expedient to change the name of Larkspur Road west of Bramalea Road in order to resolve a street numbering problem.

Notice of the intention to pass this by-law has been published once a week for four consecutive weeks in the Brampton Guardian, a newspaper having general circulation in the City of Brampton.

Council has heard all persons who claim that they would be adversely affected by this by-law and who applied to be heard.

**NOW THEREFORE** the Council of The Corporation of the City of Brampton **ENACTS AS FOLLOWS:** 

- 1. The name of "Larkspur Road: as described in Schedule A to this by-law is changed to "Black Forest Drive".
- 2. The affidavit of Leonard J. Mikulich attached as Schedule B hereto shall form part of this by-law.
