To accept and assume as public
highways certain lands shown on
Registered Plan 307

WHEREAS Haggert Avenue was dedicated as a public highway on a plan of subdivision registered in the Land Registry Office for the Registry Division of Peel (No. 43) as number G-23;


AND WHEREAS Plan G-23 was resubdivided by a plan registered in the said Land Registry Office as number 307;


AND WHEREAS it is deemed expedient to accept and assume Haggert Avenue as shown on Registered Plan 307 as a public highway;

NOW THEREFORE the Council of The Corporation of the City of Brampton ENACTS AS FOLLOWS:

1. The lands dedicated as a public highway described in Schedule A to this by-law are hereby accepted and assumed as part of the public highway system of the City of Brampton.

READ A FIRST, SECOND AND THIRD TIME AND PASSED IN OPEN COUNCIL THIS 7th DAY OF May, 1984.

SCHEDULE A TO BY-LAW 97-84

The land situated in the City of Brampton, in the Regional Municipality of Peel (formerly in the Town of Brampton, in the County of Peel) and being composed of the part of Haggert Avenue as shown on a plan of subdivision registered in the Land Registry Office for the Registry Division of Peel (No. 43) as number 307 (which plan by court order amended Registered Plan G-23, by which Haggert Avenue was dedicated as a public highway) more particularly described as follows:

COMMENCING at the northerly angle of Lot 71 according to said Registered Plan 307;

THENCE North along the westerly limit of Haggert Avenue 719.29 feet to the northerly angle of Lot 85, Registered Plan 307;

THENCE North 38 degrees 11 minutes 30 seconds East, 66.54 feet to a standard iron bar marking the westerly angle of Block F according to a plan of subdivision registered in said Land Registry Office as number 452;

THENCE South 44 degrees 30 minutes East, 720 feet to a standard iron bar marking the westerly angle of Block E according to said Registered Plan 452;

THENCE South 38 degrees 34 minutes West 66.5 feet to the point of commencement.
