Number 97-89

A By-law to amend By-law 251-82 as amended, which prohibits the running of dogs at large


WHEREAS pursuant to the Dog licencing and Livestock and Poultry Protection Act (R.S.O. 1980, c.123, as amended), and paragraphs 1 and 2 of Section 210 of the Municipal Act (R.S.O., c. 302, as amended) Council has passed a By-law prohibiting and regulating the keeping of dogs, prohibiting and regulating dogs running at large and requiring the licencing and registration of dogs within the municipality;

AND WHEREAS Council deems it desirable to amend the by-law with respect to the amount of voluntary payment to be made to the City upon the issuance of a ticket;


NOW THEREFORE the Corporation of the City of Brampton ENACTS AS FOLLOWS:

1. Schedule A of the By-law, as amended is hereby repealed and Schedule I of this by-law shall be substituted therefor?
2. Shedule B of the By-law, as amended is hereby repealed and Schedule II of this by-law shall be substituted therefor.

READ a FIRST, SECOND, and THIRD TIME and PASSED in OPEN COUNCIL this 24th day of April, 1989.
